**ORDER:**

The Election Commission of India has notified 24.04.2014 (Thursday) as the poll day for the General Elections to Lok Sabha 2014 and the Bye-election to Tamil Nadu Legislative Assembly from 28.Alandur Assembly Constituency, in Tamil Nadu. 24.04.2014 (Thursday) has to be declared as public holiday under Section 25 of the Negotiable Instruments Act, 1881 (Central Act XXVI of 1881).
